In 1970, reproductive rights activists staged a dramatic protest in the House of Commons. The protest followed a cross country abortion-rights caravan and rally on Parliament Hill with women's groups from across Canada, and was aimed at a demand for safe, legalized abortion services. Newspapers of the day were shocked by the action:

"Complete disorder and pandemonium took over in the House of Commons Monday as 31 young women rose one after another in the public gallery and screamed at startled MPs 'free abortions on demand.'" - Winnipeg Free Press

"It was likely the biggest demonstration staged by and for women ever held in Ottawa." - Toronto Telegram

"It sure as hell shook up some old MPs" - Lorne Nystom, MP, Montreal Star

The House of Commons protestors included a young Vancouver activist named Marcy Cohen, who had become involved with the Student Movement while a grad student at SFU. Marcy and other female activists at Simon Fraser University were frustrated when restricted to clerical roles in the student movement of the late 1960s. They formed what would become the Vancouver Women's Caucus, to liberate "women, the most exploited members of any society."

The VWC moved off campus, and membership increased substantially. The women's top objectives were: childcare, equal pay for equal work, contraception, and abortion access. "The most important of these revolved around a woman's right to control her own body and reproductive functions." (Roberta Lexier) The group protested the 1969 Therapeutic Abortion Committee law through demands for a repeal and guerilla theatre.

In April, 1970, Marcy was part of the VWC's "Abortion Caravan" that left Vancouver and held public meetings across the prairies. On May 9th, they rallied on Parliament Hill, then took a coffin filled with coat-hangers – representing the women who had died from illegal abortions – to the doorstep of the Prime Minister's residence. On May 11th, Marcy was one of the young women who chained themselves to their seats in the House of Commons and protested the law.

Marcy Cohen and members of the VWC are credited with kicking off the second-wave of feminism in Canada. Marcy remains committed to advancing equality rights. She is retiring from her position as the Research and Policy Director at the Hospital Employee Union, has been a Chair and Board Member of the Canadian Centre for Policy Alternatives, and was nominated for a 2010 YWCA Women of Distinction Award.

## DONOR PROFILE Ken Williams

Ken Williams is West Coast LEAF's longest planned-giving donor, first donating in 1987. Born in Vancouver, Williams left home at an early age to work in logging camps on the BC coast. His exposure to daily inequalities, living in the camps and working as a high-rigger, first spurred his interest in social justice issues.

Williams left logging in his twenties to pursue his formal education. He practiced medicine as a country doctor in Invermere, BC. His decision to stop practicing medicine and start a career in health care management and consulting took him to different medical facilities and communities in the United States. Ken and his wife returned to settle in Victoria in 1987.

He describes himself as someone who has a natural "leaning to social justice". In the logging camps, Ken recalls, speaking out against injustices was a matter of survival. He considers educating one's self and financially supporting social justice causes, as one is able, to be a matter of common sense. To be alert in society is to be asking questions, recognizing inequities as they occur, and seeking to right the wrong.

Ken is interested in senior citizens' rights and women's and minority equality issues. Living in the United Sates, he supported racial integration initiatives that championed an individual's equal rights and self-worth. Since returning to Victoria, alongside his annual financial commitment to West Coast LEAF, he supports local women's sexual assault and transition centres, including the Victoria Women's Transition House in Victoria and the Prostitute Empowerment, Education & Recovery Society (PEERS).

Ken's wife ignited his particular interest in women's equality issues. He candidly questions the foolishness of societies that end up paying for the loss of women's great potential because of condoned social conditions that subjugate and silence women, denying them equal opportunities.

Ken is proud to support women and associate himself with West Coast LEAF and has made an annual donation to West Coast LEAF since his first contribution in 1987. Speaking of West Coast LEAF, Ken comments, "I've stayed with 'em because I think they've done some great stuff...I wouldn't keep donating if I didn't think they were cutting the mustard".

He clearly specifies how West Coast LEAF is to use his donated dollars. While in full support of West Coast LEAF's litigation strategy – intervening in test cases – he chooses to support legal education initiatives and workshops. He passionately describes how his funds support the translation process from the courthouse to the streets. His funds are "to help those battles won in court be implemented in towns," so women and children across BC can understand and benefit from test case victories that set legal precedents on gender equality. The "No Means No" campaign is an example of Ken's dollars at work.

He commends the "excellent direction" of West Coast LEAF. He has developed a relationship with the organization over the years, avidly reading West Coast LEAF newsletters and calling the office with questions or comments. Ken cares deeply about women's equality issues and has made a commitment, intellectually and financially, to stay abreast of West Coast LEAF's work and to annually support the organization. He believes "you've got to be interested before you help; it is not just a matter of throwing a few bucks at them, you have to be ready to support them and stand up with them". Ken affirms this belief everyday, and West Coast LEAF is grateful for his support.

### **PROGRAM NEWS**

West Coast LEAF has a busy fall with program work and celebrating our **25th anniversary**. The film Constitute! documents the landmark activism that went into the equality sections of the *Charter of Rights and Freedoms* 25 years ago. Join us at a screening of the film on October 18 (Persons Day) that also celebrates the founding of LEAF and West Coast LEAF.

Our **2010 CEDAW report card** will measure the BC government's compliance with international standards on women's rights, including the Convention on the Elimination of all forms of Discrimination Against Women. Our annual review will record whether the BC government has made any improvements since last year's almost-failing grade.

After following the erosion of legal aid services – and especially family law legal aid – in BC over the past eight years, West Coast LEAF commends the **Public Commission on Legal Aid** for providing individuals and agencies with a chance to share their experiences and recommendations for the system. The deadline for written submissions is October 31st. Our 2010 Access to Justice petition is at www.westcoastleaf.org and our update of **Legal Aid Denied** will be released at the end of October.

West Coast LEAF is following the **Public inquiry** into the events leading to the Pickton conviction and the manner of missing women investigations. We're awaiting a decision on the issue of "public interest standing" in **SWUAV v AG Canada**, and preparing for our intervention at the BC Supreme Court in the **Reference** on the constitutionality of section 293 of the Criminal Code – the so-called "Polygamy Provision" – in November.

We're submitting comments on the **Family Relations Act** white paper and wrote to the BC Law Institute about potential changes to the employment and **Human Rights Tribunal** system. Our youth facilitators are gearing up for fall and we're planning three **Transforming Our Future** workshops around the province. Contact us to book a workshop for your class or group.
